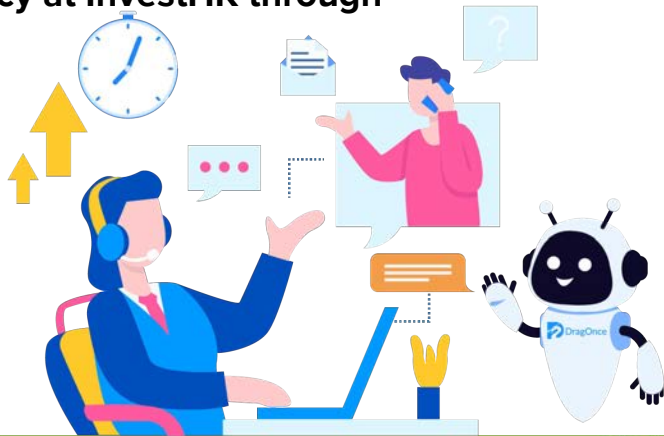
Suggested Solution:

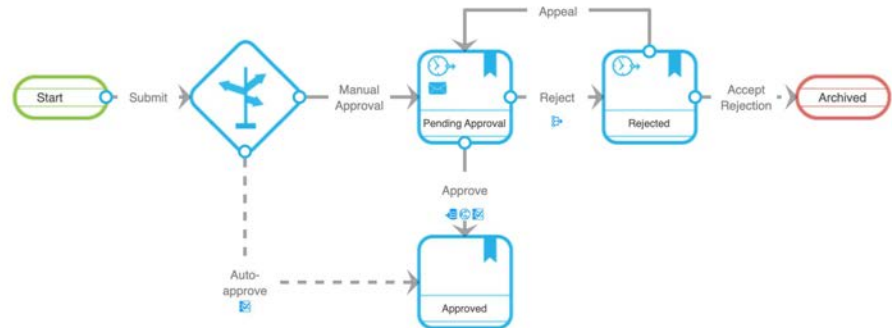
